- 1. WinnipegREALTORS® grants the EXHIBITOR the privilege to use exhibit space at the Victoria Inn, 1808 Wellington Avenue, Winnipeg, MB, during the Association's 2009 Conference and Trade Show, October 14, 2009 from 10:00 a.m. until 3:00 p.m. (Set-up from 8:00 am until 9:30 am – Centennial Ballroom)
2. Exhibit space is sold in 8 foot x 10 foot units. This includes a 6' skirted table (you may bring your own booth if you have one, provided it will fit into the designated space), 2 chairs, Wireless access is available and an electrical outlet may be purchased at an additional cost). EXHIBITORS must contain themselves to their exhibit area.
3. The EXHIBITOR will pay to WinnipegREALTORS®, the total exhibit booth fee, which is non-refundable, upon signing and delivering this Agreement to the Association. (Non-members, please include a cheque with your application made payable to WinnipegREALTORS®).
4. This Agreement is not subject to cancellation by the EXHIBITOR. However, in the event that the EXHIBITOR cannot mount a display in the exhibit area, the EXHIBITOR has the right to assign its contracted space to another exhibitor upon approval in writing from WinnipegREALTORS®, subject to all terms and conditions as set out in this Agreement.
5. Final allocation of exhibit booth space shall be at the sole and absolute discretion of WinnipegREALTORS®. If WinnipegREALTORS® decides that re-location of an exhibitor is necessary to provide a balanced ambience in the exhibit area, then the EXHIBITOR shall abide by the decision of WinnipegREALTORS®.
6. The EXHIBITOR will confine its exhibit to its exhibit booth space(s). Once the exhibit floor plan is confirmed, a copy will be sent to the EXHIBITOR in advance of the event.
